1. Use large truck jet to clear the remainder of the thick tree roots inside the pipe joint. Supply & Install a 2 meter Nuflow Reline to cover section of concrete storm water pipe that has dislodged and allowing major tree root ingress, Reline to also cover hole in the top of the pipe allowing tree root ingress.

In the event of suspension or delay of works as a result of instruction or lack of instruction from the customer/client or his/her representatives, the quoted price may be increased at the discretion of Tunnel Vision to cover extra expenses incurred thereby.

Due to the nature of the works being undertaken by Tunnel Vision and the fact that Tunnel Vision is working with aged and damaged pipes that are otherwise difficult to access, circumstances can arise that are beyond the reasonable control of Tunnel Vision that will necessitate variations to the work to be undertaken (including possible excavation) and may require Tunnel Vision to amend its quotation.

These circumstances include:-

- Damage to existing pipe works being more extensive than Tunnel Vision had reasonably anticipated;
- Any hard digging or rock breaking.
- Adverse weather conditions for example inclement weather.
- Any additional works not listed in the quotation.
- The unexpected use of the pipe being repaired by the customer or others before repairs can be completed or curing time can be completed.
