This notification seeks to advise you that APA will be undertaking maintenance work on its pipeline, some of which will be required in this location.

In preparation for the maintenance works, inspections may be required to identify any cultural heritage values that may survive on the easement. Access to this location (along the easement and agreed access roads and tracks) may be required for this preliminary inspection early February 2024

The essential components of these works are outlined below, with initial preliminary inspections commencing early February 2024:

- preliminary cultural heritage inspection
- initial pegging and minor pipeline excavation to confirm correct repair locations
- native vegetation assessment of excavation locations
- undertake potential management of any identified heritage values as required
- full targeted repair excavations of the gas pipeline
- pipeline coating inspection/removal
- repair and re-coating and
- backfill and remediation of excavated sites.

The above works are likely to result in an increase in traffic, noise and dust between 7.00am and 5.00pm. The construction team will mitigate these impacts as much as possible. Every effort will be made to minimise any interruption to your community's daily activities. The locations of the works (Digs) will be clearly identified and all safety precautions will be taken i.e. fencing around the works, clear demarcation signs to allow people to avoid the area.
